1 BACKGROUND

Bangladesh has a long (710 km) coastline in the Bay of Bengal and 76 Upazilas of 19 coastal districts are likely to be affected by rise of sea level. Consequently, around 15 million people drink saline water. In addition, millions of people are unable to collect potable water due to the lack of available safe sources in the coastal area. The lives and livelihoods of the population are affected due to water salinity, arsenic, water logging, pollution, risks from climate change, and so on. As people are not getting any pure water, they are left with no option but to be dependent on saline and shallow arsenic water which is severely detrimental to health. Such an absence of water can give rise to major disasters in the region.

Ensuring access to safe drinking water will ensure sustainable human health and socio-economic development of coastal communities. Therefore, it is urgent to sensitize the local policymakers, representatives and government officials, initiate mass campaigns and swift action to create public opinion on this crisis should be the prime priority.

The two-day strategy workshop 'WaterHackathon 2022' with an objective to create an alliance between the organizations working with drinking water issues in the coastal Bangladesh was held at CSS Ava Centre, Khulna from 7th-8th of June, 2022. A total of 27 Participants from 16 organizations participated in this workshop.

The purpose of the workshop was to share existing knowledges of the participants on coastal water issues, ongoing movement and initiatives to solve drinking water crisis and planning development to accelerate collective action on the mentioned issue.

Interactive workshop method was chosen to run the workshop. The facilitators are from within the participants themselves who lead different sessions and discussions on the workshop. The participants were actively engaged in the discussions and all the session were open for feedback, queries and suggestions. The discussions were supported through PowerPoint presentations by the facilitators.



2 OBJECTIVE

The objectives of the two-day workshop were as follow:

- > Share the existing knowledge on the water crisis in Coastal Bangladesh.
- ▶ Ennhancement of the common understanding of the water crisis.
- ▶ Demand water rights for the respected communities.
- ▶ Planning and creating a social movement to build a combined effort improving access to drinking water for all by conserving the environmental ecosystem in the coastal areas of Bangladesh.

3 PARTICIPANTS' PROFILE

20 local and national NGOs, who are working on climate change, environment, water rights issues in the coastal areas of Bangladesh. 10 Lead of the organizations, 05 expert personnels from the respective organizations and some media personnels joined this event. The total number of the participants directly or indirectly engaged and participated in the workshop is 27 and the direct participants were 20 in total.



4 PROCEEDINGS

SESSION OI WELCOME AND INTRODUCTION [WHO WE ARE, WHY WATERHACHATHON]

The workshop began with a brief introduction of Participatory Research & Action Network-PRAAN and ActionAid Bangladesh. PRAAN Chief Executive Nurul Alam Masud facilitated this introductory session. Suvendu Bishwas from AAB shared the objectives of the training. ATM Zakir

Hossain, from Jagrata Juba Sangha (JJS) warmly welcomed the participants, thanked them for their time to come and join the workshop. Moving on, an overall picture of the water crisis in coastal Bangladesh and the urgency of the issue was shared by Gouranga Nandy in his inaugural note. The norms and other logistic details were shared by Umme Salma, Programme Coordinator of PRAAN.



This session was facilitated by LEDARS Executive Director Mr. Mohon Kumar Mondol. Through his session, the participants were introduced to the burning crisis of freshwater in coastal Bangladesh. The discussion revolves around the reasons behind the crisis. Impact of the climate change, destruction of freshwater sources due to rising the sea-level and natural disasters, unplanned shrimp farming, excessive extraction of groundwater, arsenic and iron pollution, unplanned development project, lack of water preservation and management, lack of



initiatives, and water wastage was mentioned as active reasons of the suffering of the coastal communities. The specific reasons and crises were presented separately based on the southwest, southeast, and mid-coastal zones. Several stories and incidents were also presented from the ground which occurred because of the water crisis.

He shared the story of sufferings of Ms. Tumpa Khatun, a pregnant woman who has to walk almost 3 kilometers from home to collect drinking water for her family of seven members. She herself takes a little water sometimes when the stored water runs out and thus, she's suffering from several health issues. Another story was of Ms. Shahanara Begum who is suffering from backpain and leg pain caused by carrying water and walking long distances every day. She has to spend a remarkable amount of time in a day just for collecting water. Ms. Jinnatun Begum had to face a major operation of her ovary, which was caused by use of saline water. Now She is facing domestic violence due to this. A terrific incident of sexual assault happened with Ms. Taslima Khatun while she went for collecting water to help her mother in domestic chores. There are thousands more like these, he said.

Detailed discussion was held and queries of the participants were answered at the end of the session.

SESSION 03: DISCOVERING THE NEXUS BETWEEN WATER & CLIMATE CHANGE

The interlinks between water and climate change were explained by Suvendu Bishwas focusing on the several impacts of climate change on water, and the way it impacts water. An overview of the issue of why the water crisis is a climate crisis was given and the participants were oriented on the question. The facilitator also shared some videos on the issue.

SESSION OY FAMILIARITY WITH WATER MOVEMENTS

In this session, the participants were introduced to the history of ongoing water crisis-related movements in Bangladesh. Mr. Gourango Nandy elaborated on the sources available for freshwater, government initiatives, campaigns, movements, initiatives, and the reason behind the crisis elaborated in detail and this was followed by a detailed discussion. The movement for drinking water in coastal Bangladesh is somehow limited in actions like the human chain, seminars, and meetings, he said. The movements for waterlogging repulsion are rather incredible compared to these.



The NGOs worked and are working on water crises of which the actions are divided into small projects and short-term activities.

Besides this, the community people think that this crisis will be solved by the NGOs as they initiated several projects. This is high time to make the community own this issue of their selves and act accordingly. Pond-centric solutions can be effective in resolving the water crisis in coastal Bangladesh, he said. And this issue must be incorporated into the political agenda.

SESSION 05: WATER RIGHTS: POLICY & PROTECTION

Knowledge of national and international water-related policy and protection is crucial to designing an effective campaign strategy hence the participants were briefed on the water rights-related



declarations, laws, and policies. A discussion was carried out by Mr. Hasan Mehedi, Chief Executive of CLEAN in this session.

The discussion of water rights was not popular before 1978, he said. He referred to Article 25 of the UN Declaration on Human Rights and International Convent on Economic, Social and Cultural Rights (ESCR) which mention an adequate standard of living, but no direct remarks about water. The Sustainable Development Goals (SDG) directly refers to the necessity to ensure water and sanitation for all in goal no. 06. Bangladesh Delta Plan 2100 includes ensuring long-term water and food security in its mission and goal no. 02 and 06 directly refer to the right to water security and the use of water resources.

The Coastal Zone Policy of Bangladesh includes infrastructural establishment for water storage and utilization, rainwater harvesting, conservation of ponds & water tanks, and management of groundwater. The National Water Policy too is committed to facilitating the availability of safe and affordable drinking water supply, improving

efficiency for resource utilization, etc. At the end of the session, the participants contributed their thoughts and comments on the policy and protections presented.

SESSION 06. GROUPWORK MAPPING WATER HAZARDS AND ASSESS THE RISKS

This session included group work and discussion where the participants were divided into three groups based on the coastal region they are related to. They were instructed to map the water hazards in their regions and relevant risks. Mr. Hasan Mehedi facilitated the session. The hazards the groups found are more or less common.

The day was called off with the group presentations.

4. PROCEEDINGS

The day 02 of the WaterHackathon was dedicated to design campaign and advocacy opportunities, according to the objective of the workshop.

SESSION OI: SCOPING OPPORTUNITIES: CAMPAIGN & ADVOCACY

The participants were divided into three groups — SouthEast Coastal Zone, Mid Coastal Zone, and Southwest Coastal Zone. A common Google doc link was shared with the participants to enter the activities and strategies they want to follow to create a collaborative campaign for water rights in Coastal Bangladesh. Mr. Nurul Alam Masud facilitated the group work and group presentations.

SESSION 02 YOUTH FOR WATER & CLIMATE

This session began with a presentation on youth engagement and initiatives in water rights and climate in Bangladesh. Sohanur Rahman, facilitator of the session presented some remarkable youth activities focusing on water rights in Bangladesh. The probable strategies he mentioned to engage youth in water rights in future initiatives focus on initiating youth-led campaigns and projects, youth capacity building, etc. Opportunities of fellowship for youth on water rights and rewards for community-based solutions can be created to inspire more youth and their communities as well. This is high time we support and facilitate a youth-led network on water rights, he added.

- WaterMove Campaign will be a flexible network. Besides organizations, the individals who work with youth, and women issues can be engaged in this campaign.
- This campaign aims at ensuring the water rights for all in the coastal Bangladesh.
- WaterMove will work through Evidence Generation, Campaign, Advocacy, & Knowledge Sharing.
- This campaign will work ensuring access to common resources of the coastal communities.
- This campaign will take stand against those IFI's who have initiatives in commercialization and privatization of public water.
- Participatory Research & Action Network-PRAAN will host the secretariat of the campaign.
- Participatory management will be followed in campaign implementation; the responsibilities will be distributed on a rotation basis.
- The organizations working with water-related issues will/can be included/involved/colaborated in the WaterMove Campaign.
- Young people will be considered as the key actor in the planning and implementation of campaign activities.
- WaterMove will be continued as a collaborative campaign primarily. It will be formed as an alliance once run actively and successfully with consistency.
